Prevention of harm from alcohol use during pregnancy is of rapidly growing concern in many countries. The International Conference on Prevention of FASD will be the first event of its kind to focus entirely on this important subject.

Distinguished speakers from around the world will present facts and findings from research, and describe innovative approaches for prevention of harm from alcohol use during pregnancy.

During panel sessions, findings from effective interventions in various contexts will be analyzed and discussed. Plenary sessions will deal with such issues as successful approaches to primary prevention of FASD; prevention of FASD in various communities around the world; the tailoring of messages on FASD to different target groups; controversies in the field of FASD; secondary and tertiary prevention of FASD; and the impact of broad policies on alcohol use and the social determinants of health. A synthesis of the findings will be published in the proceedings of the conference.

An expected outcome of the conference is the dissemination of a charter document that will serve policy making efforts around the globe. A draft “Edmonton Charter on Prevention of FASD” will be presented to the conference and reviewed and discussed by all participants.

The aims of the conference are to:

- Share experiences of effective strategies to prevent harm from alcohol use during pregnancy.
- Contribute to the development of appropriate approaches to primary, secondary and tertiary prevention, and identify the most important tools for effective prevention of FASD at different levels of the health, educational, social and justice systems.
- Assist public policy decision makers by providing evidence on strategies for prevention of FASD in both the short and long term.
- Discuss and seek resolution on many controversial issues surrounding FASD.
- Increase public awareness of the need to prevent harm from alcohol use during pregnancy.
- Develop the “Edmonton Charter on Prevention of FASD.”

HONORABLE ALLISON REDFORD

Allison Redford was elected leader of the Alberta Progressive Conservative Party on October 1, 2011 and sworn-in as Alberta's 14th premier on October 7, 2011. Alison has been actively involved in both provincial and national politics since the 1980s. She served as Senior Policy Advisor to the Right Honourable Joe Clark when he was Secretary of State for External Affairs, and later worked in the Prime Minister's Office. In this capacity, she organized a series of national consultations facilitating public input on federal white papers concerned with foreign affairs and defense. In Parliament, she was also the Principal Legislative Advisor to the Secretary of State for External Affairs. Throughout the 1990s, Alison worked as a technical advisor on constitutional and legal reform issues in Africa for the European Union, the Commonwealth Secretariat and both the Canadian and Australian governments. Her work in Africa focused on human rights litigation, education programs and policy reform initiatives. In 2005, Alison was appointed by the Secretary General of the United Nations as one of four International Election Commissioners to administer Afghanistan's first parliamentary elections. She also served as an advisor to the Privy Council Office on Canada's future involvement in Afghanistan. Over the course of her career, Alison has also undertaken assignments in Bosnia and Herzegovina, Serbia, Namibia, Uganda, Zimbabwe, Mozambique and the Philippines. Before seeking elected office in Alberta, she managed a judicial training and legal reform project for the Ministry of Justice and the Supreme People's Court in Vietnam. Alison Redford was elected MLA for the constituency of Calgary-Elbow on March 3, 2008 and named Minister of Justice and Attorney General on March 12, 2008. In this role, she led the Safe Communities Secretariat. In January 2010, she was also named political minister for Calgary.



DR. STERLING CLARREN

Dr. Sterling Clarren is the CEO and Scientific Director of the Canada Northwest FASD Research Network and clinical professor of Pediatrics at the University of British Columbia and the University of Washington. Since 1975, Dr. Clarren has applied his training in dysmorphology, neuropathology, neuroembryology, and developmental pediatrics to the problems of fetal alcohol spectrum disorders in clinical diagnosis, clinical evaluation and intervention, and clinical and basic research. Dr. Clarren wrote the first major summary article on the clinical pattern of malformation associated with alcohol teratogenesis in the New England Journal of Medicine in 1978. He was co-author of the 4-Digit Diagnostic Code for FAS and related conditions. This last work has recently been accepted, with minor modification, as the Canadian standard for FASD diagnosis. Dr. Clarren developed one of the first pediatric clinics focused on the diagnosis of FAS and related conditions in 1978, and has refined the clinical approach over many years. In 2001 he was given the Henry Rosett Award by the Fetal Alcohol Study Group of the Research Society on Alcoholism in recognition of "outstanding clinical insight, leadership, and research". In 2006, he received the Award for Career Excellence from the National Organization for FAS in Washington DC. He lectures internationally and has recently been a distinguished visiting professor at both Queen's University and McGill University.



DR. EDWARD RILEY

Dr. Edward Riley is a Distinguished Professor in the Department of Psychology and the Director of the Center of Behavioral Teratology in San Diego State University. He has authored over 225 scientific papers and reviews and served as Chair of the U.S. National Task Force on FAS/FAE from 2000 to 2004. He currently serves on the Expert Panel for the SAMHSA FASD Center for Excellence. He has served as President of the Research Society on Alcohol, the Fetal Alcohol Study Group, and the Behavioral Teratology Society. He has served on several editorial boards and is currently a reviewing editor and on the Editorial Board of *Alcoholism: Clinical and Experimental Research*. He has received numerous awards for his scholarship and service, including the Research Society on Alcoholism Distinguished Researcher Award and the National Organization on Fetal Alcohol Syndrome Research Recognition Award. His work on FASD has been funded by the National Institute on Alcohol Abuse and Alcoholism since 1978.



MS. NANCY WHITNEY

Nancy Whitney, M.S., L.M.H.C. is the Clinical Supervisor for the King County Parent Child Assistance Program (PCAP), a program of the University of Washington Fetal Alcohol and Drug Unit in the Alcohol and Drug Abuse Institute. She is a Licensed Mental Health Counselor and a clinically-certified forensic counselor. Ms. Whitney contributes to ongoing research and to the development of interventions for high risk populations, and she has co-authored research papers and a book chapter on these issues. Ms. Whitney has been a mental health professional in community settings for 20 years. She has worked in all treatment settings with patients who are chronically mentally ill and have co-occurring disorders. She regularly provides training to professionals who serve the community's most difficult clients, on topics including Fetal Alcohol Spectrum Disorders, case management, and clinical interventions. Nancy Whitney, M.S., is Clinical Supervisor for the King County Parent Child Assistance Program (PCAP) in the University of Washington Fetal Alcohol and Drug Unit. She is a licensed mental health counselor and a clinically-certified forensic counselor. Ms. Whitney contributes to ongoing research and to the development of interventions for individuals with Fetal Alcohol Spectrum Disorders. She regularly provides training to professionals and has co-authored research papers and a book chapter on these issues.



DR. PHILIP MAY

Dr. Philip May is a sociologist/epidemiologist who has specialized in public health research and prevention for 40 years. Dr. May was a commissioned officer in the United States Public Health Service from 1969 to 1973, working for the National Institute of Mental Health in Washington, D.C. and the Indian Health Service at Fort Hall, Idaho, and Pine Ridge, South Dakota. He has been a Professor of Sociology and a Professor of Family and Community Medicine at the University of New Mexico since 1978. Dr. May's research on fetal alcohol spectrum disorder (FASD) epidemiology, maternal risk factors, and behavioural traits and educational intervention for children with FASD began in 1979 with the first-ever population-based study of fetal alcohol syndrome (FAS) epidemiology. It was carried out among American Indians in the Southwestern U.S. His work has been funded by several federal agencies including the National Institute on Alcohol Abuse and Alcoholism (NIAAA), the Indian Health Service (IHS), the Health Resources and Services Administration (HRSA), and the Centers for Disease Control and Prevention (CDC). Dr. May's clinical research teams have studied FASD in populations in New Mexico, Arizona, southern Colorado, Montana, South Dakota, North Dakota, South Africa and Italy.



DR. ALBERT CHUDLEY

Dr. Albert Chudley is a professor at the University of Manitoba and is Medical Director of Winnipeg's Regional Health Authority Program in Genetics and Metabolism. He is a medical geneticist and pediatrician with decades of experience in the etiology of genetic and teratogenic disorders that cause birth defects and/or intellectual disabilities. He has published over 350 peer-reviewed articles, book chapters and abstracts on these topics. Dr. Chudley has had a particular interest in the recognition, diagnosis, prevention and intervention strategies related to Fetal Alcohol Spectrum Disorders (FASD). He is the lead author of the paper describing the Canadian Diagnostic Guidelines for FASD. He served on Health Canada's National Advisory Committee on FASD. He is a current member of the National FASD Screening Tool Steering Committee. He was recently appointed a Team Lead in the FASD stream of the NeurDevNet, established by the National Centres of Excellence. He previously served as a Board member on the Canada Northwest FASD Research Network, and remains a member of the clinical network. Dr. Chudley has research expertise in the prevalence of FASD in schools, communities and various regions in Canada and abroad. He has done research in rural communities and studies in various at-risk populations. He was a co-principal investigator in a study to determine prevalence of FASD in a Canadian federal prison. Dr. Chudley has been a consultant to provincial, national and international organizations and governments on issues related to FASD. He was co-Chair of the Second International FASD meeting in Strasbourg, France, in December 2011, and co-organizer of a national meeting in Winnipeg in October 2011 on the prevalence of FASD in Canada.



MR. JODY ALLEN CROWE

Jody Allen Crowe spent 18 years as an educator on reservations in northern Minnesota and elsewhere. In 1992, he designed and implemented a middle school on the Leech Lake Reservation that was presented the Blue Ribbon School Award from President Clinton in 1995. As the Mille Lacs Reservation Early Childhood, K-12 principal, he led their school to the 2002 National Indian School Board Association School of the Year award for the 184 Bureau of Indian Education schools. While there, he designed and implemented an Ojibwe Language program that was awarded the John F. Kennedy Harvard School of Business Award High Honors designation. He served for two years as superintendent of the Shoshone Bannock School in Fort Hall, Idaho. From there, he moved into charter school administration, serving as Executive Director of two charter schools in southern Minnesota. In 2008, his book, "The Fatal Link", connecting school violence and prenatal exposure to alcohol was published. Crowe founded and serves as the Executive Director of Healthy Brains for Children, a charitable nonprofit, with a singular mission of preventing prenatal exposure to alcohol. Healthy Brains for Children has led the effort to establish community-based chapters to focus on prevention in their community. He continues to speak on his research into school shooters and train, as well as consult, on issues surrounding prenatal exposure to alcohol. In July, 2012, he led Healthy Brains for Children's initiative to place a pregnancy test dispenser in women's restroom in a bar in Minnesota. This initiative brought international attention to the issue of prenatal exposure to alcohol in unexpected pregnancies. The initiative has grown to include other communities in Minnesota and Ontario, with interest from all around the world.



MS. MARGARET MURRAY

Dr. Murray is Director of the Global Alcohol Research Program, National Institute on Alcohol Abuse and Alcoholism, National Institutes of Health. Dr. Murray directs NIAAA's efforts in international research collaboration spanning each of the Institute's priorities in biomedical, epidemiological, prevention and treatment research. This includes serving on U.S. Science and Technology Committees, NIH and government wide initiatives in global health, and representing NIAAA to multilateral organizations such as the World Health Organization and the National Academies of Sciences committees. She is primarily responsible for facilitating collaborative relationships at the individual institute and scientist level. Dr. Murray is also responsible for the Institute's research translation initiatives in health professions education. She is co-author of A Medical Education Model for the Prevention and Treatment of Alcohol-Use Disorders, a twenty module curriculum and faculty development course for medical school faculty in the primary care specialties. The model has been translated into five languages and implemented in eight countries. She led the development of a model curriculum for social work educators, A Social Work Education Model for the Prevention and Treatment of Alcohol Use Disorders that is currently being disseminated and tested by NIAAA, and is also involved in a similar project in nursing education. She has published in the areas of screening and brief intervention for alcohol use disorders in primary health care settings, evaluation of international faculty development programs and homelessness and alcohol and drug problems. Dr. Murray also serves as adjunct faculty in the graduate programs at the Catholic University of America and Howard University where she teaches courses in the history of Social Welfare Policy in the United States.



DR. THOMAS A. McLELLAN

Dr. A. Thomas McLellan is the CEO and co-founder of the Treatment Research Institute (TRI) and an experienced substance abuse researcher. From 2009 to 2010, he was Science Advisor and Deputy Director of the White House Office of National Drug Control Policy (ONDCP), a congressionally confirmed Presidential appointment to help shape the nation's public policy approach to illicit drug use. At ONDCP, McLellan worked on a broad range of drug issues, including formulation and implementation of the President's National Drug Control Strategy and promotion of drug treatment through the broader revamping of the national health care system. Dr. McLellan has more than 35 years of experience in addiction treatment research. In 1992, he co-founded and led TRI (until his ONDCP appointment) to transform the way research is employed in the treatment of and policy making around substance use and abuse. He has published over 400 articles and chapters on addiction research. From 2000 to 2009 he was Editor-in-Chief of the Journal of Substance Abuse Treatment, and he has served on several other editorial boards of scientific journals. Dr. McLellan is the recipient of several awards, including the Life Achievement Awards of the American and British Societies of Addiction Medicine (2001 and 2003); the Robert Wood Johnson Foundation Innovator Award (2005); and awards for Distinguished Contribution to Addiction Medicine from the Swedish (2002) and Italian (2002) medical associations. In the 1980s, with his colleagues from the Center for the Studies of Addiction at the University of Pennsylvania, Dr. McLellan introduced the Addiction Severity Index and, later, the Treatment Services Review. Both are among the most widely used assessment instruments in the world.

PLENARY SPEAKERS



DR. SUSAN ASTLEY | Dr. Astley received her B.S. in Biology, her M.S. in Radiology and Physiology, and her Ph.D. in Epidemiology. She is a member of the American Association of Public Health and the Research Society on Alcoholism and is a Research Affiliate at the Center on Human Development and Disability at the University of Washington. Dr. Astley has conducted laboratory, clinical, and public health research in the field of FASD since 1981. Current work has been in the development and implementation of FASD diagnostic, screening, surveillance, and prevention tools and programs. This work includes the development of the FASD 4-Digit Diagnostic Code and FAS Facial Photographic Analysis

Software; establishment of the WA State FAS Diagnostic and Prevention Network of clinics and Foster Care FAS Screening Program, and establishment of the FASD diagnostic training program and Online Course. She and her colleagues have recently published a comprehensive study of the diagnostic utility of MRI, MR-spectroscopy and functional MRI for FASD. Three additional focal publications include: 1) Washington State's success in preventing FAS through reduction of maternal alcohol use during pregnancy, 2) Clinical profiles of 1,400 patients with prenatal alcohol exposure, and 3) Diagnosing FASD. She has received funding from NIAAA, CDC, SAMHSA, the National March of Dimes, the Alcohol and Drug Abuse Institute,



DR. ILONA AUTTI-RÄMÖ | Dr. Ilona Autti-Rämö is a pediatric neurologist in Helsinki, Finland, and a European leader in the field of research on FASD, beginning with her PhD thesis on the effects of in-utero alcohol exposure on children in the first three years of life. She has published more than 60 peer-reviewed articles on FASD in English as well as other research, and for the past decade has been the principal investigator for Finland in a multinational study on FASD (CIFASD) funded by the NIAAA. Dr. Autti-Rämö is currently Research Professor and Chief of Health Research at the Social Insurance

Institution in Finland, and a member of the scientific committee of EUFASD. She has previously served as chief physician in the Finnish Office for Health Technology Assessment, Chair for the National Electronic Patient Record Subcommittee on Research, Registers and Leadership, and Secretary of the National Screening Committee of the Ministry for Social Affairs and Health. She is a peer reviewer for a wide range of scholarly journals in both English and Finnish.



DR. DOROTHY BADRY | Dr. Dorothy Badry, PhD, RSW, is an Assistant Professor in the Faculty of Social Work, University of Calgary. Her research interests focus on FASD, birth mothers and families of children with FASD, substance abuse-related social problems for women and families, and disability advocacy. Dr. Badry is an active member of the Canada FASD Research Network. She has received funding for research projects from the Alberta Centre for Child, Family and Community Research, the Public Health Agency of Canada, and the First Nations and Inuit Health Branch of Health Canada. Current and recent co-principal investigator research projects include the FASD Community of Practice Research and Brightening Our Homes Fires: An Exploratory FASD Prevention Project in the NWT with women in four northern communities. She recently completed an international systematic review of assessment and diagnosis of FASD among adults. Dr. Badry has developed and is teaching a course on FASD and child welfare practice in collaboration with the University of Calgary,

University of Regina and the University of Manitoba.



DR. TATIANA BALACHOVA | Dr. Tatiana Balachova, PhD, is a clinical psychologist who graduated from St. Petersburg State University, Russia, and completed a postdoctoral fellowship in Pediatric Psychology and Child Abuse and Neglect at the University of Oklahoma Health Sciences Center (OUHSC), where she gained extensive experience in research focused on substance abuse, child maltreatment, and FASD prevention. Dr. Balachova has over 20 years of experience working in areas of child maltreatment and substance abuse in the U.S. and Russia. She has served as principal investigator on a number of studies and as advisor for the WHO and other organizations. Currently, Dr. Balachova is an

Associate Professor of Pediatrics at OUHSC and is Principal Investigator on an NIH-funded study to evaluate a FASD prevention intervention in Russia, and Co-Director of the Interdisciplinary Training Program in Child Abuse and Neglect (ITP) for graduate students.

PLENARY SPEAKERS



MR. LAURI BEEKMANN | Lauri Beekmann has been the chairman and executive director of the Estonian Temperance Union (ETU) since 2003. In 2013, Lauri took over the responsibilities of the Secretary General of NordAN (Nordic Alcohol and Drug Policy Network). With a background in journalism, he has worked as a radio editor for 10 years and as an editor of different local magazines and portals. In 2007 he started an alcohol news blog and weekly alcohol-related newsletter – <http://alcoholweekly.blogspot.com/>. He is also the editor of bimonthly newsletter for the European FASD Alliance network and is currently vice-president of the European Alcohol Policy Alliance (Eurocare) and board member of the Baltic Tobacco and Alcohol Control Coalition (BTACC).



DR. DIANE BLACK | Dr. Diane Black is the adoptive mother of three children with Fetal Alcohol Spectrum Disorder. She is the chairperson of the newly founded European FASD Alliance. The goals of this nonprofit organization are to support member associations in various European countries in their efforts to prevent FASD and improve the quality of life of persons living with FASD. She is a member of the board of the Fetal Alcohol Syndrome Foundation of the Netherlands, whose activities include a Dutch-language website, newsletters, distribution of folders to professionals for use in counseling pregnant women, and maintaining a Dutch-language mail group for parents of children with FASD. One of her main interests is the role of nutrition in management of FASD. She has given presentations on this topic, and started an e-mail discussion group on Nutrition for FASD. She holds a PhD. from Purdue University (1986), and previously held various positions as researcher at the University of San Diego, Hoefer Scientific (San Francisco), INSERM (Strasbourg) and Marion Merrell Dow Research Institute (Strasbourg). Since the adoption of her three children with FASD, she has devoted her time to her children and other FAS-related activities. She speaks fluent English, Dutch and French.



DR. ELIZABETH ELLIOTT | Elizabeth Elliott AM is a Professor in Paediatrics and Child Health at The University of Sydney; a Consultant Paediatrician at The Children's Hospital at Westmead, Sydney; and a National Health and Medical Council of Australia (NHMRC) Practitioner Fellow. She is Founder/Director of the Australian Paediatric Surveillance Unit, established in 1993 for the study of rare childhood diseases, and heads the Centre for Evidence Based Paediatrics, Gastroenterology and Nutrition in Sydney. She leads an education program in Maternal and Child Health in Vietnam. Elizabeth has been involved in clinical service delivery, research and policy development regarding Fetal Alcohol Spectrum Disorders (FASD) for 12 years. Past research includes a national surveillance study of FAS; surveys of women and health professionals regarding their knowledge of and attitudes to alcohol use in pregnancy and FASD; and studies of women hospitalized for alcohol-related conditions during pregnancy. Currently she is a chief investigator for a project to develop national screening and diagnostic tools for FASD. Since 2009 Elizabeth has been involved as a research collaborator and clinician in the Lillivan Project, a community-led initiative to establish the prevalence of FASD in the Fitzroy Valley. This is part of a strategy called Marulu, which addresses prevention of FASD and provision of support to caregivers and families of people living with FASD. She is also investigator on two birth cohort studies evaluating child outcomes of alcohol and other substance use in pregnancy. She was a member of The Royal Australasian College of Physicians' Alcohol Policy Working Party; the Intergovernmental Committee on Drugs Working Party on FASD; and the NHMRC committee to review the Australian Alcohol Guidelines published in 2009. In 2012 she was involved in developing a national action plan for FASD and has provided information to the House of Representatives Inquiry into the Prevention and Management of FASD. In 2008 she was made a Member of the Order of Australia for service to pediatrics and child health.



DR. DON FUSCH | Dr. Don Fusch is a professor at the Faculty of Social Work at the University of Manitoba. He has conducted extensive research on the role of social networks and social support in strengthening parenting ability and preventing child maltreatment. His current program of research focuses on establishing the prevalence and costs of children with disability in care, and examining the determinants that result in children with disabilities (particularly FASD) coming into care and their experiences while in care. He is also conducting research on youth with FASD transitioning out of care. He has done extensive international social development work in Russia, Ukraine and Ghana for the past 12 years as part of CIDA-funded projects. He served as Dean of the Faculty of Social Work at the University of Manitoba for 11 years, and was a founding participant in the Prairie Child Welfare Consortium. He has been instrumental in the development of a graduate curriculum relating to social practice and Child and Family Services at the University of Manitoba and other prairie universities.

PLENARY SPEAKERS



DR. ERICKSON FURTADO | Dr. Erikson Furtado, MD, PhD, started his medical career in 1984 as pediatrician and became a child psychiatrist in 1986 and earned his PhD in Child Psychiatry at the University of Heidelberg, Germany, in 1993. Since 1995, he is a full-time tenured faculty member of the University of Sao Paulo (USP, Brazil), as Assistant Professor of Psychiatry with the Department of Neuroscience and Behavior, School of Medicine at Ribeirao Preto (FMRP). He is responsible for the Child and Adolescent Psychiatry Unit and its Residency and Fellowship Program and is the founder and coordinator of the "PAI-PAD" program (Program of Integrated Actions for Prevention and Attention to Alcohol and Drugs in the Community). He opened an outpatient unit devoted to the, from childbirth beginning, longitudinal assessment and psychiatric care of FASD children and developed a protocol for alcohol brief interventions for pregnant women as a mean of FASD prevention. His "PAI-PAD" program, funded by the State Health Department of Sao Paulo, is now promoting continuing training and resources for the implementation of preventive and early diagnosis and treatment for alcohol and drugs at the primary health care level in Brazil.



DR. AKINORI HISASHIGE | Dr. Akinori Hisashige is the director of the Institute of Healthcare Technology Assessment in Japan. His primary research areas are healthcare technology assessment, evidence-based health care, and health economics. He is a pioneer in these areas in Japan. He has served as a member of governmental advisory committees related to health technology assessment and evidence-based healthcare. He received the award for the best article in the International Journal of Health Care Technology Assessment in 1993. He has authored more than 250 papers and 25 books.



DR. STUART MACLEOD | Dr. Stuart MacLeod, MD, PhD, FRCPC, has been Professor of Pediatrics at the University of British Columbia since 2003. He was Director of the Child & Family Research Institute at BC Children's Hospital until 2010 and Vice President Research for the Provincial Health Services Authority of British Columbia until 2012. Previously, Dr. MacLeod spent 14 years at the University of Toronto with appointments in the departments of pharmacology, clinical biochemistry, medicine and pediatrics and an adjunct appointment in the Faculty of Pharmacy. At The Hospital for Sick Children, beginning in 1979, Dr MacLeod established the Division of Pediatric Clinical Pharmacology which has become a world leader in research and training of clinician scientists with an interest in pediatric therapeutics and toxicology. In 1987 Dr MacLeod became Dean of the Faculty of Health Sciences at McMaster University and in 1993 established a

multidisciplinary program in therapeutic evaluation, the Centre for Evaluation of Medicines. His main research interests at the present time are pediatric clinical pharmacology and toxicology, adverse drug reactions, pharmacogenomics, drug policy and optimal drug use for children. Dr MacLeod has longstanding involvements in health professional education and global health that have included work in Africa for international agencies and organizations, including the World Health Organization, Canadian International Development Agency, International Development Research Centre, the Bill & Melinda Gates Foundation and the Rockefeller Foundation.



DR. MALCOLM KING | Dr. Malcolm King is a member of the Mississaugas of the New Credit First Nation. He is a health researcher at Simon Fraser University, Faculty of Health Sciences in Vancouver, BC. In his career in pulmonary research, Malcolm has developed new approaches to treat mucus clearance dysfunction in chronic lung disease, and is now working on addressing issues in airborne disease transmission. Since January 2009, he has led the CIHR Institute of Aboriginal Peoples' Health as its Scientific Director. In this role, he leads the development of a health research agenda aimed at improving wellness and achieving health equity for First Nations, Inuit and Métis Peoples.



DR. CARMEN KREFT-JAÏS | Dr. Carmen Kreft-Jaïs MD, is special advisor to scientific director of Inpes (National Institute for Prevention and Health Education) in Saint-Denis, France, with a particular interest in alcohol and pregnancy, alcohol in women of childbearing potential, non-transmissible chronic diseases, and Alzheimer's. She is a Senior Consultant in Clinical Pharmacology, Department of Pharmacology at the European Hospital Georges Pompidou in Paris. Previously she was the Director of Regional Pharmacovigilance Centre and Head of the Pharmacovigilance Department at Afssaps (French Medicines Agency). Dr. Kreft-Jaïs participated as the French delegate at the European Pharmacovigilance Working party at the European Medicines Agency and at the WHO National Collaborating Centres.

DR. JACQUELINE PEI | Dr. Jacqueline Pei is an Assistant Professor in the Department of Educational Psychology and Assistant Clinical Professor in the Department of Pediatrics at the University of Alberta in Edmonton. Also a practicing Registered Psychologist for the past 10 years, Dr Pei began her career as a criminologist and forensic counselor working with incarcerated youth. Motivated by this early work, she returned to academia to study youth at risk, child development, and neuropsychology, leading to her current focus on interventions for individuals with FASD. Building on her work with various community and government agencies, including serving on the FASD Clinical Diagnostic Team at the Glenrose Rehabilitation Hospital, Dr Pei currently leads the Intervention Network Action Team (iNAT) for the Canada FASD Research Network.



DR. NANCY POOLE | Dr. Nancy Poole is well known for her collaborative work on FASD-related research, training and policy initiatives with governments and organizations at the local, provincial and national levels. Since 1996, she has worked with BC Women's Hospital and the BC Centre of Excellence for Women's Health on research relating to policy and service provision for women with substance-use problems. On behalf of the Centre of Excellence and BC Women's Hospital, she currently leads province-wide professional training and resource development for the ActNow BC, Healthy Choices in Pregnancy initiative. With Dr. Amy Salmon, she is a Co-Leader of the Network Action Team on FASD Prevention of the Canada Northwest FASD Research Network. Dr. Poole has recently co-edited a book with Dr. Lorraine Greaves, entitled *Highs and Lows: Canadian Perspectives on Women and Substance Abuse*, published by the Centre for Addiction and Mental Health in Ontario. She holds fellowships with IMPART and NEXUS and is the 2009 Healthway Health Promotion Visiting Research Fellow sponsored by Curtin University and the Government of Western Australia.



DR. SVETLANA POPOVA | Dr. Svetlana (Lana) Popova, MD, MPH, Ph.Ds is an Independent Scientist of the Social and Epidemiological Research Department at CAMH. She is also Assistant Professor of the Dalla Lana School of Public Health, Epidemiology Division and Factor Inwentash Faculty of Social Work, University of Toronto. Dr. Popova has a particular interest in the epidemiology, economic cost, prevention, and intervention strategies related to FASD. Currently, she is a Principal Investigator (PI) of the study on estimation of burden and economic cost of FASD in Canada, supported by the Public Health Agency of Canada. She is also a PI of the study on estimation of prevalence of FASD among elementary school children in Ontario, Canada. Dr. Popova is a co-PI of World Health Organization International Study on Global FASD Prevalence supported by the National Institute on Alcohol Abuse and Alcoholism. Dr. Popova collaborated on the WHO Global Burden of Disease studies on alcohol consumption as a risk factor for burden of disease. She was also one of the conductors of the second Canadian Cost Study on Substance Abuse and Avoidable Cost of Alcohol Abuse in Canada.

PLENARY SPEAKERS



DR. AMY SALMON | Dr. Amy Salmon is the Coordinator of Sheway, a Clinical Assistant Professor at the School of Population and Public Health at the University of British Columbia, and a Collaborating Scientist at the Centre for Addictions Research of BC at the University of Victoria. Her research examining the primary health care and health education needs of substance-using women and mothers, and developing intervention strategies for FASD prevention, has been funded by the Canadian Institutes of Health Research, the Michael Smith Foundation for Health Research, the Social Sciences and Humanities Research Council, and the Victoria Foundation. She is the co-editor of *Alcohol, Tobacco, and Obesity: Morality, Mortality, and the New Public Health* (Routledge Press, 2011) and *Prevention of Fetal Alcohol Spectrum Disorder: Who is Responsible?* (Wiley-Blackwell, 2011), and her publications appear in journals such as *Critical Public Health*, *The International Journal of Drug Policy*, *Nursing Inquiry*, and *Social Science and Medicine*.



DR. CUDORE SNELL | Dr. Cudore L. Snell, Dean & Professor has taught and conducted research at Howard University School of Social Work for the past 23 years. He received his Bachelor of Arts Degree in Social Work and Psychology from the University of the Western Cape, South Africa and a Bachelor of Social Science Honors Degree in Psychiatric Social Work from the University of Cape Town. He obtained a Doctor of Social Work Degree from Howard University. He was a Fulbright-Hayes Scholar on sabbatical leave in South Africa from 1999 to 2000 and conducted research on fetal alcohol syndrome (FAS) and comparative work on street youth. He is currently engaged in FAS prevention research in his hometown, Wellington, SA. He has served on various professional and editorial boards and was a guest editor on a special issue on African Partnerships for the new *Journal of Social Work and Public Health*. He was the immediate past Chair of the Global Commission for Social work Education at CSWE and he was a board member for NASW at the metropolitan and national levels. He is also an ex-officio board member of National Association of Deans and Directors of Schools of Social Work.



DR. SUZANNE TOUGH | Dr. Suzanne Tough is a Professor with the Departments of Paediatrics and Community Health Sciences in the Faculty of Medicine at the University of Calgary and a Health Scholar supported by the Alberta Innovates – Health Solutions. She is also the Scientific Director of the Alberta Centre for Child, Family and Community Research, an organization whose vision is to improve child, family and community well-being through applied research. Her research program focuses on improving health and well-being of women during pregnancy to achieve optimal maternal, birth and early childhood outcomes. Suzanne is also the Principal Investigator of the All Our Babies Study, a cohort with 3,300 mother-child pairs that is investigating the impact of genetic and environmental factors on maternal-child health. The underlying aim of her research program is to optimize birth and childhood outcomes by creating evidence that informs the development of community and clinical programs and influences policy. Her research also extends to Fetal Alcohol Spectrum Disorders and is focused on healthcare practices and prevention approaches prior to and during pregnancy, as well as alcohol use and screening.



DR. NAZARIUS MBONA TUMWESIGYE | Dr. Nazarius Mbona Tumwesigye is a senior lecturer in the Department of Epidemiology and Biostatistics, School of Public Health, Makerere University College of Health Sciences in Kampala, Uganda. He holds a masters degree in medical statistics from the London School of Hygiene and Tropical Medicine and a PhD with a bias to social statistics from the University of Southampton. He has authored and co-authored a number of papers relating to alcohol epidemiology and the effects of alcohol abuse. He is also a chair for the 39th conference of the Kettil Bruun Society for Social and Epidemiological Research on Alcohol (KBS) that will take place June 3-7, 2013, in Kampala, Uganda. KBS conferences promote scientific knowledge of the epidemiological and social aspects of alcohol use.



DR. ELENA VARAVIKOVA | Elena A. Varavikova was born in Alma-Ata, Kazakhstan, USSR and studied medicine and public health at the Moscow Medical Academy named after I.M. Sechenov. She completed her Ph.D. in Moscow, an M.P.H. degree at the School of Public Health at the State University of New York in Albany, and postdoctoral studies at the Harvard University School of Public Health. She served as Chief of the Unit for Monitoring of Health and Preventable Deaths at the Research Institute for Public Health Organization and Information, Russia, as well as Associate Professor of Public Health at the Moscow Medical Academy. Recruited to WHO-HQ in 2002-2006 she has worked on strategies for improvement in health services coverage; human resources for health, in patient safety. Later in Russia she has worked for the Federal Agency for High-tech Medical Care, where she was a State Adviser for the Russian Federation. She has leaded and participated in a number of projects in many countries and has published on public health topics including the “New Public Health” textbook, written in English, translated in 9 languages (published by Elsevier, authors: T/Tulchinsky and E. Varavikova) Now she is a leading researcher at the Federal State Research Institute for the Information and Organization of Public Health (CNIIOIZ) and Co- chair of

Service in 1982 for his work in development of the first Surgeon General's Advisory on FAS. In 2007, the National Organization on Fetal Alcohol Syndrome (NOFAS) honored Dr. Warren by placing his name into their Tom and Linda Daschle FASD Hall of Fame, followed by the receipt of the NOFAS Excellence Award in 2008.



DR. MAGGIE WATTS | Dr. Kenneth R. Warren, Dr. Watts is a consultant in public health medicine, having trained in general (family) practice and public health. Dr. Watts has had a long standing interest in alcohol issues and has been working with fetal alcohol harm issues since 2004. In 2011 she was appointed as a part time national FASD coordinator for Scotland - the first such post in the UK, where her role is to develop and drive forward FASD policy and practice. She has recently completed a Winston Churchill Travelling Fellowship, visiting Finland and Canada to research what Scotland can learn and apply from their approaches to fetal alcohol harm.



DR. JOANNE WEINBERG | Dr. Dr. Joanne Weinberg is a Professor and Distinguished University Scholar in the Department of Cellular & Physiological Sciences at the University of British Columbia. She is a member of the Brain Research Center, and an Associate Member of the Department of Psychology and of the Developmental Neurosciences and Child Health Research Cluster at the Child and Family Research Institute. Dr. Weinberg has served on the Board of Directors and the Education and Program Committees of the Research Society on Alcoholism, and as President of the Fetal Alcohol Spectrum Disorders Study Group. She currently serves on the Advisory Panel of the Intervention Network Action Team, Canada FASD Research Network and as a Co-leader of the FASD Project of NeuroDevNet, a Network of Centers of Excellence. Dr. Weinberg has also served on the Editorial Advisory Boards of Neurotoxicology and Teratology, Physiology and Behavior, Alcohol, and Alcoholism: Clinical and Experimental Research. In 2007, Dr. Weinberg received the Henry Rosett Distinguished Researcher Award from the FASD Study Group. The research in Dr. Weinberg's laboratory utilizes a rat model to examine the long-term effects of prenatal alcohol exposure on brain and biological development, with a particular focus the development of neuroendocrine and immune function. This research is helping to elucidate mechanisms underlying the increased incidence of "secondary" disabilities such as mental health and behavior problems in children with Fetal Alcohol Spectrum Disorders. Dr. Weinberg's work has been funded by the BC Health Research Foundation, the BC Ministry for Children and Family Development (through the UBC Human Early Learning Partnership), the Canadian Foundation for Fetal Alcohol Research, CIHR, and for more than 25 years, by the US National Institutes of Health/ National Institute on Alcohol Abuse and Alcoholism.



DR. WADIEH YACIOUB | Dr. Wadie Yacoub is a Public Health and Preventive Medicine specialist working as the Medical Officer of Health and Director of Health Protection, Health Assessment and Surveillance with the First Nations and Inuit Health Branch of Health Canada in the Alberta Region. His areas of responsibility include Communicable Disease Control, Environmental Health Services and Health Assessment and Surveillance in First Nations communities in Alberta. He is also clinical assistant professor in the department of Medicine, Preventative Medicine Division at the University of Alberta, the department of Community Health Sciences at the University of Calgary, as well as the School of Public Health at the University of Alberta. Dr. Yacoub currently participates in various Public Health working groups and advisory committees at the provincial and federal levels. He is a member of the Alberta Council of Public Health physicians and the national First Nations and Inuit Health Branch's Council of Physicians in Public Health. Dr. Yacoub has led and /or participated in various communicable disease outbreak or cluster investigations. He greatly enjoys working with Public Health teams to address the First Nations community health issues and is a 'believer' in the value and power of prevention.

An important satellite initiative occurring in conjunction with the conference is the creation of The Edmonton Charter on Prevention of FASD. The aim of the Charter is to meet the widespread global demand for a broad based, high level action plan to reduce the incidence of FASD and to prevent secondary and tertiary consequences from this disability. This will be the first document on this important subject.

The Charter will be based on evidence presented at the conference. All those who attend the conference will be sent a draft version of the Charter. The last afternoon of the conference (Wednesday September 25th from 1:00-2:00) will be dedicated to a Town Hall discussion of the Charter, where delegates will be able to provide their input and help shape this historical document. This Town Hall discussion presents a unique opportunity to develop a Charter on which the whole community of participants from different countries and international organizations can agree, endorse, and form a consensus around.

YOUTH INITIATIVE

INSTITUTE OF HEALTH ECONOMICS YOUTH AMBASSADORS FOR FETAL ALCOHOL SPECTRUM DISORDER (YA-FASD)

Occurring as a satellite initiative of the conference, the Institute of Health Economics has created the Youth Ambassadors for FASD (YA-FASD) program. Recognizing that activities directed towards youth are more impactful when youth are involved in the initiative, the YA-FASD is an innovative way to include youth in the discussion of FASD prevention. Twenty highly influential youth from across the province of Alberta are involved in this initiative, which aims to:

- promote education and increase awareness of FASD among youth, a generally hard-to-reach population;
- create a useful curriculum and set of resources which are attractive to youth to be used to increase awareness about FASD in their communities/schools;
- build capacity among youth to achieve a self-sustainable youth movement on prevention of FASD.



The youth will attend a series of two, two-day training workshops (pre and post-conference). At the first workshop the youth learned about FASD, including both prevention and the connections with the law. The first day of this workshop was dedicated to education, while the second day was spent creating educational materials discussing the disorder.

Ambassadors will be attending the conference, so be sure to say hello.

After the conference, the Ambassadors will attend a second workshop to examine and discuss what has been learnt, and to review and propose edits to the printed materials developed at their first workshop. The educational materials developed through the YA-FASD will be used to educate future youth about the disorder, and will help identify what youth view as important considerations surrounding FASD.



DOWNTOWN PEDWAY MAP






